

**Town of Stockton Board Meeting Minutes  
Tuesday, September 29, 2009, 7:00 pm  
At 7252 6<sup>th</sup> Street Town Hall**

1. **Call to Order:** Chairman Mike Bronk called the Town Board meeting to order at 7:00 pm.  
**In attendance: Supervisors Dodge and Piesik, Clerk Helminiak and Treasurer Walters.**
2. **Approval of agenda** (Dodge/Piesik) to move agenda item # 12 to be #3. Motion carried 3-0.
3. **Change the names of Lovers Lane, Duck Trail and BJ Court** Discussed and decided to try stronger breakaway posts and street signs to prevent theft.
4. **Approval of the minutes;**
  - Motion (Piesik/Dodge) to approve **August 24, 2009** minutes as amended. Motion carried 3-0.
  - Motion (Dodge/Piesik) to approve **September 9, 2009** minutes as presented. Motion carried 3-0.
5. **Anyone wishing to Address Board/Announcements/Correspondence**
  - Supervisor Dodge called the DOT and questioned the status of the grant to reconstruct the Old Hwy 18 railroad crossing. No reply at this time.
6. **Report by the Fire Dept.**
  - Report given by Chief Mike Spencer stating 2 calls had been made this last month.
  - Questioned if Town insurance covers fire fighters and EMS from the time they leave home till they are on site.
  - All FEMA grant supplies have arrived and fire fighters are being trained to use them, especially the extricator.
7. **Report by the EMS**
  - 46 calls for the year to date.
  - One new recruit is in training,
  - EMS president Jerry Eron demonstrated the diabetic treatment care kit and how it has been changed to be more effective and at less cost.
8. **Barking Dog Ordinance** Need more research.

8. **Resolution to increase garbage fees to \$122.00** postponed till next meeting because of change of grammar.
9. **Discussion of 3 year contract for ambulance service** Supervisor Dodge reported that a three year contract would increase the effectiveness of the Ambulance Service because over three years, three attendants would be added to the service. Motion (Dodge/Piesik) motioned to have the Town Chair complete the survey agreeing to a 3 year contract, with Portage County for ambulance service.
10. **Approval of Bartenders License** Motion (Dodge/Piesik) to approve for bartenders license for Eric Krszjaniek. Motion carried 3-0.
11. **Update of eradication of Eurasian water milfoil on Bear Lake and Lake Thomas**
  - E-mail report by the DNR stating that the chemical control of the water milfoil at Bear Lake was very good. The vast majority of EVM have been wiped out and the needed native plants are flourishing. The few remaining EVM plants could be spot controlled next year.
  - No report on Lake Thomas.
12. **Future agenda items.** Position of flags at graves on vet holidays
