

**Town of Stockton Board Meeting Minutes**

- 1. Call to Order:** Chairman Mike Bronk called the Town Board meeting to order at 8:00am

**2. Robert Sankey, 7786 Lake Thomas Rd.** Stevens Point, WI 54482

- a. Parcel # 034-23-0915-08.04, Request: Change from A-1 zoning to A-3 zoning  
Land Use L-3 Property location: 7722 Lake Thomas Rd.

- b. Parcel # 034-23-0915-08.02, Request: Change from A-1 zoning to A-3 zoning. Land Use  
L-3, Property location: 7786 Lake Thomas Rd.

Motion (Dodge/Piesik) to approve change in zoning from A-1 to A-3 for the above two  
mentioned parcels as recommended by the Plan Commission. Motion carried 3-0.

**3. Betty Wanta, WantaTompson Revocable Trust, 7796 Lake Thomas Rd.**

Stevens Point, WI 54482, Parcel # 034-23-0915-08.01 Request: Change from A-1  
zoning to A-3 zoning. Land Use L-3. Property location: 7796 Lake Thomas Rd.

Motion (Piesik /Dodge) to approve change in zoning from A-1 to A-3 for the above  
mentioned parcel as recommended by the Plan Commission. Motion carried 3-0.

**4. Road Projects for 2010 and the effect of prevailing wages.**

- Discussed 2010 road work to be an overlay on Deer Road and possible rebuilding  
sections of 4<sup>th</sup> St. and wedging of 6<sup>th</sup> St. American Asphalt had submitted budget  
figures for these projects.

Motion (Dodge/Piesik) to group all projects together for the prevailing wage application and  
publish bids for the same using either hot or cold mix. Motion carried 3-0.

- Discussed agriculture use in area affecting roads.
  - a. Farmers planting crops up to edge of asphalt.
  - b. Using the road to turn heavy machinery around thus eliminating ditches.
  - c. Destroying edge of asphalt and roads.
- Letter will be mailed to them previous to restoring ditch and fine them for future  
destructions of local roads.

referendum.
- Add DOT to April 12 agenda to discuss questions on upgrading of Old Hwy 18 railroad  
crossing
