

Town of Stockton Board Meeting Minutes
Monday July 12, 2010, 7:00 pm
At 7252 6th Street Town Hall

1. **Call to Order:** Chairman Mike Bronk called the Town Board meeting to order at 7:00 pm.
 - In attendance: Supervisors Dodge, Piesik, Clerk Helminiak and Treasurer Walters.
2. **Approval of agenda** Motion (Piesik/Dodge) to approved agenda with item #7 moved to # 3. Motion carried 3-0.
7. **Grant for Town Park** Request redrawn.
3. **Approval of minutes**
 - Motion (Dodge/Piesik) to approve **June 28, 2010** Board minutes. Motion carried 3-0.
 - Motion (Piesik/Dodge) to approve **July 6, 2010** Board of Review minutes. Motion carried 3-0.

5. **Treasurers Report/Actual vs. Budget Report** presented by Treasurer Walters showing balance on hand as of June 30, 2010 of \$338,595.54. Motion (Dodge/Piesik) to accept as presented. Motion carried 3-0. Actual vs. Budget discussed.
6. **Bills/Checks** Motion (Piesik/Dodge) to approve check # 25661 to 25725 and checks #100603, 100604 and 100701 & 100702. Motion carried 3-0.
8. **Unfinished road right of way by fiber optic contractor**
 - Damage has been done by bulldozer on the edges of the roads on Rolling Hill, Oak Road and Edgewood while burying fiber optic cables.
 - Workers do not have any safety equipment on or follow safe practices with equipment. Motion (Dodge/Piesik) for Chairman Bronk to draft a letter to MI-Tech about the complaint and forward copies of the letter to the Amherst Telephone Co. and Wisconsin Public Service Commission. Motion carried 3-0.
9. **Accident traffic report for 2009.** Supervisor Dodge had the Sheriff's Dept. work up a report stating the number and type of traffic accidents there have been in the Town of Stockton in 2009. There were 60 traffic accidents in the Town in 2009 and 15 of them were on town roads with a majority of them involving deer, Thus indicating that lowering the speed limit would have no effect on the number of accidents in the Town.
